

Who we are

The Jerramungup Community Resource Centre has 3 overarching objectives for our business. We provide access to services, information and training not readily available in rural areas. We promote the CRC, CRC Network, and our community through our events and workshops, community newsletter and tourism centre. The Jerramungup Community Resource Centre is integral in fostering a sense of community as we produce the local newsletter, 'The Jerry Journal' in addition to engaging the business and social community through our various workshops, events, and training opportunities. The Management Committee and staff are committed to make a rural community feel less remote by providing access to services and opportunities usually only found in larger centres.

Jerramungup is a small rural community in the Great Southern region. It is approximately 180 km north of Albany, 300 km east of Esperance with these being the closest major centres. Conveniently located at the gateway to the Fitzgerald National Park, the town has developed into the one stop shop before tourists and locals enter the National Park or head to the coastal town of Bremer Bay.

Jerramungup is situated in the Fitzgerald Biosphere where the farmers and local community groups work together to protect the natural vegetation and landscapes. Currently, the region supports sporting activities, mixed farming activities, agriculturally related contract businesses, and other community groups. Tourism is currently an area of focus, not only for the Shire of Jerramungup and its town revitalization project, but also for the Jerramungup Community Resource Centre and its addition of a tourism centre.

The Shire of Jerramungup's population according to the most recent Australian Bureau of Statistics data is 1217 with approximately 899 domestic dwellings. There are two major streets in the town of Jerramungup holding approximately 11 businesses as well as a light industrial precinct. Jerramungup also has a District High School that caters for children from Kindy to Year 10. The businesses and high school draw patronage and students from an immediate surrounding area of approximately 150km. The Shire of Jerramungup contains the additional localities of Jacup, Fitzgerald, Needilup, Gairdner, and Bremer Bay.

Chairperson's Report

What a year 2024/2025 has been.

We began the year farewelling our incredibly dedicated staff member, Charlotte, as she moved from Jerramungup. She was an asset to the centre and the community, and her departure has been strongly felt. Taparah, our Trainee also left the team and later in the year we welcomed Kirstie back. Fiona Murray, our Centre Manager, ended her service with our team in September. She was a valued member of the centre and was often helping community members with their needs. She coordinated the staff and events well and we wish her all the best for her future endeavours.

With Fiona's departure we welcomed Krissy Hindley into the position of Centre Manager. We are incredibly excited for Krissy to start with us and have already seen some positive steps forward in her learning of the role and the management of the centre. Due to the local Childcare service closing on certain days, we have had to adjust and now have a casual relief staff roster helping us on the days our permanent staff are unable to work. These ladies have also proved to be a welcomed addition to the team and Krissy has been working with them to increase their skills in certain areas.

Although our centre has had several staffing changes this year, the staff and committee have still maintained an excellent level of service and events. Our Men's Group and Ladie's Group – led by local community members- continues to grow in strength and are vital to the mental health and wellbeing of some of the members. It has been fantastic to see different members of the community

joining these groups. Our afterschool activities are also still proving quite popular with the youth of the town. Youth Space continues to grow and is valued by several parents in the town.

Our Annual Biggest Morning Tea event was once again a success raising vital funds for cancer research. Our centre was also successful in acquiring the Black Dog Grant and held a Movie event to raise awareness of Mental Health and Wellbeing, and the resources available for people in rural areas. We hope to continue with these movie events to help raise awareness to the community.

This year I was fortunate enough to have our Secretary, Jill, attend the DPRID conference in my absence. She brought back lots of helpful information and I am very grateful she could take time out to attend this event. Later in the year I was able to attend the Linkwest conference, and this provided lots of networking opportunities for myself and the chance to see what other centres were struggling and succeeding with. These events are fantastic, especially for those of us in volunteering roles and I would like to thank DPRID and Linkwest for their support and providing these opportunities.

With our staffing changes we are still advertising for a Finance Officer. I would like to say a huge thank you to Elizabeth for temporarily stepping in to the Finance position making sure our centre is still running financially.

Finally thank you to the dedicated committee members of our centre. The time and commitment by these volunteers is second to

none and without it our centre would certainly not function as smoothly as it has with these changes. I look forward to working with our Staff next year and welcome all new committee members to our team.

I'm looking forward to the new challenge of leading our CRC team and continuing to strengthen the services and support that we provide to the community of Jerramungup.

I would like to begin by sincerely thanking the Committee and staff for their support throughout the past year. As Centre Coordinator, I have continued to develop my skills through the guidance and expertise of our committee members, along with training opportunities provided by Linkwest and DPIRD. With the encouragement of both the Committee and staff, this role has been an incredibly rewarding experience both personally and professionally.

Our current team includes Viktorija (Administration/Customer Support), Kirstie (Trainee – Certificate III in Business), Esther (Junior Administration Officer), and myself as Centre Coordinator. Viktorija, who joined us in November 2023, has been a valuable addition to the team. Her background in IT and programming has enriched our children's educational programs through engaging design classes using computers and iPads. Kirstie has brought great enthusiasm to her role and is eager to progress in her studies, while Esther, who began in early 2024, has quickly gained confidence and skills, particularly in the SPYDUS library system.

Each staff member has continued to grow in their role and contribute meaningfully to the Centre's success. Their dedication and teamwork have been vital in supporting our services and programs.

This year, the Jerramungup CRC has also delivered a range of training opportunities and social events for community members and local businesses, all of which have been well supported and positively received.

As many of you are aware, I will be stepping down as Centre Coordinator. At the time of writing, a replacement has not yet been appointed, and we anticipate some changes ahead as the Committee works through this transition. I am confident that with the continued commitment of our staff and the strong support of the Committee, the Centre will move forward positively and continue to serve the community well.

Over the past twelve months, the Jerramungup Community Resource Centre has proudly delivered a wide range of training opportunities, social programs, and community events,

responding to local needs and strengthening connections across our community.

Training Courses

We continue to provide accessible training in collaboration with key partners, ensuring community members and businesses can access upskilling opportunities locally. In 2024–25, the following courses were delivered:

- *First Aid* (4 sessions)
- *AusChem Full Course* (2 sessions, delivered by TAFE Katanning)
- *Working Safely at Heights* – 2 day (2 sessions, delivered by TAFE Katanning)
- *Confined Spaces* – 2 day (2 sessions, delivered by TAFE Katanning)
- *Forklift* – 2 day (2 sessions, with thanks to Homestead Hardware Jerramungup for supplying the forklift)
- *Mental Health First Aid*, provided free of charge by CBH for community members
- *Small Business Workshops*, delivered monthly by Albany Business Centre (October 2024, and January–June 2025) to support local businesses, associations, and individuals

Community Programs

- *Men’s Club* – Established in 2025 to provide a safe, non-judgemental environment for men to connect. Members meet every Wednesday over coffee and biscuits for conversation and support.
- *Ladies’ Group* – Originating as a craft group, this has evolved into a social gathering space where craft is still enjoyed, alongside broader social connection.
- *Youth Space* – Supported by a \$5,000 grant from the Department of Communities, Youth Space was launched in Term 1, 2025 as a six-month project for young people aged 12–18. Due to its popularity and impact, the program has continued under

the Empowering Communities Program, providing a safe, inclusive place for youth to connect and learn.

- *Children’s Afterschool Sessions* – Delivered throughout 2024/25 with themes such as healthy eating, local birdlife, and creative design using programs like Canva. These sessions have encouraged curiosity, creativity, and skill-building in local children.
- *Tuesday Morning 0–5 Program* – Held weekly during school terms (36 sessions in 2024/25), these sessions have focused on early literacy and numeracy, providing a valuable learning and social opportunity for young children and their families.

Our staff continue to update their knowledge and skills to ensure children’s programs remain engaging, educational, and responsive to community needs.

Partnerships and Collaboration

Collaboration remains at the heart of our service delivery. We:

- Work closely with *Southwest Regional TAFE* and *St John’s Albany* to coordinate training delivery.
- Maintain a strong partnership with *Jerramungup District High School* and its P&C, including initiatives such as *Countdown to Kindy*.
- Strengthened relationships with training providers, who regularly provide positive feedback on our facilities and staff support.

Events and Community Grants

- The *Biggest Morning Tea* was once again a success, and we are already registered to host the 2026 event, with preparations to begin in March.
- Each term in 2024/25, we were successful in securing *Community Enrichment Grants* from *Amity Health* (\$1,000 per term) to

support the 0–5 Tuesday sessions and the Afterschool Program.

Year in Summary



Government Services

Government Access Point

Through our government access point, we provide free access to online and print resources related to local and state government agencies. Through the Access Point, clients with lack of internet access or limited computer skills can navigate government websites to gain information or lodge forms without having to travel or wait to speak with an operator at a call centre.

Department of Human Services

Our patrons can access the Department of Human Services at our Centre via phone, internet or fax. In 2023-24 we have noted fewer DHS patrons using our facilities; clients are becoming more tech-savvy and utilising their tablets and smart phones for lodging DHS claims at home. We do, however, still have on-site clients that require the use of our access point, especially for uploading documents and those who need assistance using a computer.

Videoconferencing Connections

Our video conferencing office is private and well-organised. It is comprised of a meeting area (desk and chairs) and modern video conferencing equipment. Our staff can assist clients with setting up videoconferencing appointments/equipment, allowing the clients to conduct personal business privately and without the hassle of travel.

Shire of Jerramungup

We have held an agreement with the Shire of Jerramungup to provide library services on the Shire's behalf. Through the funding we receive from the Shire, we can ensure all staff employed at the Jerramungup Community Resource Centre are provided with the necessary skills to deliver library services at a

high standard, supply new resources to the patrons, keep the public library up to date with the latest information and offer a monthly Story Time event for young children.

Department of Communities : Empowering Communities Program

In December 2018, the Jerramungup CRC was awarded a 5-year contract with the Department of Communities to provide services under the Empowering Communities Program. In June 2024 the program was extended for a further 5 years. This Program aligns well with our current service model and will enhance our ability to provide opportunities for community development. The five (5) main aims of the Program are: people feel safe, people contribute, people participate, people learn, and people are connected.

The independent auditor report was completed by Tommy Lam at Macleod Corporation and has been included at the end of this report.







NOTE 1 – STATEMENT OF ACCOUNTING POLICIES

The Committee of Management have prepared the financial statements on the basis that the entity is a non-reporting entity because there are no users dependent on general purpose financial reports. This financial report is therefore a special purpose financial report that has been prepared to meet Committee of Management's financial reporting requirements under the Jerramungup Community Resource Centre Inc constitution.

The financial report has been prepared in accordance with the significant accounting policies disclosed below, which the Committee of Management have determined are appropriate to meet the needs of the members. Such accounting policies are consistent with the previous period unless stated otherwise.

The financial report has been prepared in accordance with the requirements of the Associations Incorporation Act 1987 of Western Australia and the following Australian Accounting Standards:

AASB 101, Presentation of Financial Statements
AASB 107, Statement of Cash Flows
AASB 108, Accounting Policies, Changes in accounting Estimates and Errors
AASB 1031, Materiality
AASB 1048, Interpretation of Standards
AASB 1054, Australian Additional Disclosures.

No other applicable Accounting Standards, Australian Accounting Interpretations or other authoritative pronouncements of the Australian Accounting Standards Board have been applied.

The financial report has been prepared on a modified accrual basis of accounting including the historical cost convention and the going concern assumption.

The following material accounting policies, which are consistent with the previous periods unless otherwise stated, have been adopted in the preparation of the financial report:

a) Income Tax

Income taxation exemption.

Jerramungup Community Resource Centre Inc is a not for profit organisation incorporated under the Associations Incorporations Act 2015 and has self assessed and determined that it is entitled to income tax exemption under section 60 of the Income Tax Assessment Act, 1936.

No change in its tax status as a result of activities undertaken during the year is likely.

b) Cash and Cash Equivalents

Cash and cash equivalents includes cash on hand, deposits held at call with banks, and other short-term highly liquid investments with original maturities of three months or less. Bank overdrafts are shown within short-term borrowings in current liabilities on the statement of financial position.

c) Inventories

Inventories held for resale have been valued at the lower of cost and net realisable value.

d) Investments

Investments comprise available-for-sale financial assets designated as available-for-sale, but which are not deemed to be held principally for trading purposes, and include equity investments. Investments are initially recognised at fair value plus transaction costs.

Subsequent gains or losses arising from changes in fair value are included as a separate component of equity in the available-for-sale revaluation reserve except for interest, dividends and foreign exchange gains and losses on monetary assets, which are recognised directly in the income statement. When the investment is sold, the cumulative gain or loss relating to the investment is transferred from the available-for-sale revaluation reserve to the income statement.

e) Property, Plant and Equipment (PPE)

Plant and equipment including leasehold improvements are measured on the cost basis less depreciation and any impairment losses.

Impairment losses, **in accordance with Accounting Standard AASB 136 "Impairment of Assets"** is the amount by which the carrying amount of an asset or a cash-generating unit exceeds its recoverable amount. The recoverable amount of an asset is the higher of its fair value less costs to sell and its value in use. Fair value less costs to sell is the amount obtainable from the sale of **an asset in an arm's length** transaction between knowledgeable, willing parties, less the costs of disposal.

Right of use assets where a lessee is granted the right to use an asset over the life of the asset (together with the lease payment obligation liability) have not been brought to account, which is **otherwise a requirement of AASB16 "Leases"**.

Materiality

Assets with an economic life in excess of one year are only capitalised where the cost of acquisition exceeds materiality threshold of \$ 1,000.

Depreciation

The depreciable amount of plant and equipment is depreciated on a diminishing value and **straight line basis over the asset's useful life to the entity commencing from the time the asset is held ready for use**. Leasehold improvements are depreciated over the shorter of either the unexpired period of the lease or the estimated useful lives of the improvements.

The depreciation rates used for each class of depreciable assets are:

f) Employee Benefits

No provision has been made for the Centre's **liability for employee benefits arising from services** rendered by employees to the end of the reporting period. The Centre is expected to do so in future and employee benefits will be measured at the amounts expected to be paid when the liability is settled.

g) Provisions

Provisions are recognised when the Centre has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result, and that outflow can be reliably measured. Provisions are measured at the best estimate of the amounts required to settle the obligation at the end of the reporting period.

h) Revenue and Other Income

Non-reciprocal grant revenue is recognised in profit or loss when the entity obtains control of the grant and it is probable that the economic benefits gained from the grant will flow to the entity and the amount of the grant can be measured reliably.

When grant revenue is received whereby the entity incurs an obligation to deliver economic value directly back to the contributor, this is considered a reciprocal transaction and the grant revenue is recognised in the statement of financial position as a liability until the service has been delivered to the contributor, otherwise the grant is recognised as income on receipt.

The fair value of volunteer services contributed has not been recognised in accordance with **AASB 1058 "Income of Not for Profit Entities". As a consequence, no volunteer labour expense** and correspondingly no volunteer income has been brought to account.

Donations and bequests are recognised as revenue when received.

Interest revenue is recognised as it accrues using the effective interest method, which for floating rate financial assets is the rate inherent in the instrument.

Dividends are recognised as revenue when received.

Revenue from the rendering of a service is recognised upon the delivery of the service to the customers.

i) Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Tax Office. In these circumstances, the GST is recognised as part of the cost of acquisition of the asset or as part of an item of the expense. Receivables and payables in the assets and liabilities statement are shown inclusive of GST.

j) Going Concern & Economic Dependency

The accounts have been prepared on a going concern basis. The ability of the centre to continue as a going concern is dependent upon continued support from the Jerramungup community and government agencies. At the date of this report the committee have no reason to believe that Jerramungup community and government agencies will not continue to fund the operations of the Centre.

k) Comparatives

Comparative figures for the previous year have been reclassified to conform to the new format financial report.


